



What is "#STOPtheTREATY" Campaign about?

The campaign aims to highlight the importance of the upcoming WHO Treaty to "Strengthen Pandemic Prevention, Preparedness and Response" and further more, to oppose the signing away of our sovereignty to an unelected and privately funded international organisation, and promote the retention of our democratic Irish State.

What is the Treaty proposed by the W.H.O. about?

On 1 December 2021, 194 members of the World Health Organization reached a consensus to begin the process of drafting and negotiating agreement (Treaty) under the Constitution of the World Health Organization, to strengthen pandemic prevention, preparedness and response.

How could this Treaty impact you?

This treaty threatens the loss of control over our nations independent decisions around health, our own individual bodily integrity and the fundamental right to choose our own healthcare.

What are the main concerns with such a Treaty?

If the Treaty is ratified, Ireland could face the introduction of mandated medical procedures, further lockdowns, possible EU sanctions for non compliance, fines or punishments on an individual level and loss of individual rights to bodily integrity.

Ireland would lose sole control over managing public health based on our demographics, population size and other key factors that should be considered when making such decisions.

The public must also be made aware that the WHO is largely funded by private organisations.

The second largest contributor and the largest private donor is a private entity, the Bill and Melinda Gates Foundation who funded the WHO to a tune of 1 billion in 2021.

The Bill & Melinda Gates Foundations are heavily involved with vaccine production and the pharmaceutical industry.

It is important that the public are aware of such private donations and the conflicts of interest that can arise and may influence public health decisions.

Another consideration to note is that serious concerns have been raised regarding the Director-General of the WHO, Dr Tedros, who has been indicted to the International Criminal Court for war crimes during his reign in Ethiopia.

Will you be able to vote for or against this Treaty?

Ireland has not yet been asked to vote by Referendum on the question of whether they 'support' a 'binding legal instrument on pandemic preparedness and response'.

When is it due to be implemented?

The WHO aim to adopt the instrument by 2024.

Where can I read this Treaty and find out more?

The Treaty has not yet been published for review.

The WHO council is currently working on a draft and the exact stipulations are unknown.

We expect a document for public review to be published early 2023.
