What is herd immunity?

Herd immunity is the indirect protection from an infectious disease that happens when a population is immune either through vaccination or immunity developed through previous

Infection. This means that even people who haven't been infected, or in whom an infection hasn't triggered an immune response, they are protected because people around them who are immune can act as buffers between them and an infected person. The threshold for establishing herd immunity for COVID-19 is not yet clear.

In November 2020, a Danish study ⁽¹³⁾ (which the governments of Europe have chosen to completely ignore) of over 6000 people by the Copenhagen University Hospital stated that:





- face masks may only offer the wearer limited protection against COVID-19 infection.
- Researchers found there was no statistically significant difference in the number of people who contacted the virus in a group wearing masks in public compared to a group that did not do so.

This has been further backed up by a recent study by Stanford University which stated: "The data suggest that both medical and non-medical facemasks are ineffective to block human-to-human transmission of viral and infectious disease such SARS-CoV-2 and COVID-19, supporting against the usage of facemasks". ⁽⁶¹⁾

If masks are so effective, why have we had such rises in cases since they have been mandated indoors in public spaces since November 2020?

Most people wear cloth masks, snoods or disposable surgical masks. These are not designed to prevent the escape of vapour molecules or protect you against Covid 19 and they are also only designed for single use – not repeat use.

Surgeons dispose of their surgical masks <u>after each use</u>. The general public are mostly re-using masks on a regular basis. These masks will collect dirt and dust particles & contaminants which are then being inhaled by the individual which is not healthy

In November 2020, in a **Portuguese Court Case**⁽¹⁶⁾ it was ruled that "a single positive PCR test cannot be used as an effective diagnosis of infection". The ruling goes on to conclude that, based on the science they read, any PCR test using over 25 cycles is totally unreliable. America's Anthony Fauci has publicly stated "anything over 35 is totally UNUSABLE."(17)

Irish government paid test houses are using 35-45 cycles. THIS IS FRAUD!!

Boris Johnston when questioned about mandatory testing at UK airports stated that the PCR tests led to a very high amount of "<u>false positives with a rate of as high as 93%</u>"

People received positive Covid PCR test results even though they did not take a test. This was highlighted on 4FM's Niall Boylan Radio Show. Again, this is fraud by our government.

In March 2021, Ireland is now mandating mandatory hotel detention if the traveller does have a negative PCR test result. In the diagram to the right, the flu cases in week 13 of 2019 was approx. 21,000 versus just under 4000 in week 13 in 2020 (23rd to 29th March).



This is a reduction in positive flu specimens by 81% with less than 1000 number in the first week of April which is generally flu season

The European Court of Justice said there was not enough evidence put forward to show the Working Time Directive was not being implemented

THE EUROPEAN COURT of Justice has rejected a bid to have Ireland fined over the long hours worked by junior doctors.

The European Commission had claimed the Department of Health was in breach of the Working Time Directive by asking the non consultant hospital doctors (NCHDs), or junior doctors, to work 24 hour shifts.

However the court today said there was not enough evidence put forward to show the directive was not implemented. It also said arguments had been made which explained irregular shifts are sometimes necessary to keep staffing levels within standards at all times.

The court recognised that training time does not constitute working time as the doctor is not available for work purposes.

Is the real reason that the HSE are so short on staff numbers currently because healthcare workers are being deemed "close contacts"?

Most of these staff had no symptoms & were forced to stay off work.
